

**Florida Gold Coast LMSC
Meeting – December 15, 2013**

1. The meeting was called to order by Vice Chair, Debbie Cavanaugh at the Coral Springs Aquatic Complex at 2:29 pm.

Roll Call was taken by the secretary, Jonathan Olsen. During roll call confirming voting members present, a discussion began about the interpretation of the votes by team representatives. The interpretation suggested was to allow one team representative cast all votes allotted to the team rather than the usual manner that the group voted, one vote for each rep present. Motion by Linda Bostic, 2nd Richard Garza, To follow the By-Laws Article 4 Section A.: "...the number of votes for each club representative shall be based on the total number of athletes registered with that club ..." Motion passed.

Deb Cavanaugh received proxies from Matt Hooper and Andrea Woodburn. Jonathan Olsen received a proxy from Dale Leclair.

2. Corrections noted to minutes, Approval of minutes from last meeting on June 19 2013 motion to approve by Marty Hendrick, 2nd by Lisa Bennett, pass with unanimous approval.

3. Reports of Officers

A. Chair – none

B. Vice Chair – Debbie Cavanaugh reposts the convention was a good learning experience. Everything seems to be running smoothly in the LMSC.

C. Treasurer – Cav Cavanaugh reports that last year we ended the year with about \$45k and this year to 12/15/13 we expect to end the year with about \$46k. He recommends that the annual \$2 increase in USMS membership could continue to be absorbed as a way to spend the money. He requests suggestions for ways to spend the money. He reports that sending 6 people to the Convention this year was about \$6000.

D. Secretary – Jonathan Olsen, present, no report.

Cav Cavanaugh motioned to accept officer reports, Barb Protzman 2nd, motion passed.

4. Reports of Committees

Officials –Steven Goldman reminds all of the FINA rule change that two hand touches

must have a separation of hands.

Registrar – Barb Protzman reports the LMSC has 1202 members to date for 2013 vs 1192 in 2012, a record membership. To date, only about ¼ of the membership has renewed for 2014. A five digit membership ID code is now available for a \$50 fee.

Newsletter – Barb Protzman thanks everyone for the recent articles for the LMSC and Dixie Zone newsletters.

Sanctions – Andrea Woodburn requests that Meet Director wait for sanction approval prior to publishing or distributing meet information.

Open Water/Long Distance – Andrea Woodburn reported that three events this year were not sanctioned or recognized.

Top Ten – Chela Devaney asks swimmers and coaches to double check that the meet attended are sanctioned or recognized by USMS. Also asks meet directors to not accept entries without prior confirmation of membership.

Richard Garza motioned to accept committee reports, Peggy McDonell 2nd, motion passed.

5. Unfinished Business

Brief reports about Convention attendance by Richard Garza, Marty Hendrick, Barb Protzman, Deb Cavanaugh and Cav Cavanaugh.

6. Election of Officers

Chair - Ann Thomas nominates Marty Hendrick for Chair, 2nd Richard Garza. Cav Cavanaugh nominated Matt Hooper, Peggy McDonald 2nd.

Vice Chair – Marty Hendrick nominates Richard Garza, Linda Bostic 2nd. Barb Protzman nominates Lisa Bennett, 2nd Peggy McDonald.

Treasurer – Cav Cavanaugh nominates Kristen Volz, Ann Thomas 2nd.

Secretary – Deb Cavanaugh nominates Jonathan Olsen, Steven Goldman 2nd.

Motion by Steven Goldman to accept the Treasurer and Secretary by acclamation, 2nd Barb Protzman, approved. Voting for Chair and Vice Chair, Marty Hendrick and Richard Garza are elected the new Chair and Vice Chair, respectively.

Motion by Peggy McDonell to destroy the ballots, 2nd Tommie Cuticchia, approved.
